### Superficies licence applications submitted

- The Estonian Maritime Spatial Plan approved in 2022:
  - covers both the terrotorial waters and Economic Zone
  - determines areas, guidelines, and conditions for development



# First wave projects in EIA phase

- Saare Wind Energy OÜ up to 1400 MW, 167 km<sup>2</sup>
- Utilitas Wind OÜ (Saare-Liivi)
  3200 MW, 307 km<sup>2</sup>
- Enefit Green OÜ (Liivi laht) up to 1000 MW, 184 km<sup>2</sup>



## Second wave

#### Auctions held

- Sea area Liivi 1 UAB "Ignitis renewables projektai 6", up to 900 MW, size 77,7 km<sup>2</sup>
- Sea area Liivi 2 UAB "Ignitis renewables projektai 6", up to 1400 MW, size 114,9 km<sup>2</sup>



## Saare 1

- Auction from 27th Feb 2024 at 12:00 (UTC+2) to 29th Feb 2024 at 12:00 (UTC+2)
- Area 88,0 km<sup>2</sup>
- Capacity 820-1200 MW
- Starting price 1 320 000 €



Saare 2.1, Saare 2.2, Saare 3

- Intention to initate superficies licence proceedings announced
- Ongoing submission of competing applications up to 1st of April 2024 at 11.59 p.m
- Auction of all 3 areas is taking place 2nd quarter 2024
  - Saare 2.1 up to 1700 MW, size 163, 8 km<sup>2</sup>, starting price 2 457 000 €
  - Saare 2.2 up to 1040 MW, size 88,5 km<sup>2</sup>, starting price 1 327 500 €
  - Saare 3 up to 149 MW, size 20,1 km<sup>2</sup>, starting price 301 500 €



#### Establishment of superficies licences (up to 50 years)

- Notice on application in Ametlikud Teadaanded
- Submission of competing application within 60 days
- Assessment of competing applications -> notification at least 30 days before auctions
- Admitting auction's participants -> deposit fee (2% of starting price), approval of application 3 working days
- Auction -> online, starting price 15 000 eur/km<sup>2</sup>
- Initiation of superficies licence proceedings -> up to 90 days
- EIA programme for approval -> 18 months
- EIA report for approval -> 24 months
- Issue of building permit (valid 5 years) –> 5 years after approval of superficies licence





### Acceleration - changes in Bulding Code

- Accelerating the development of renewable energy plans by streamlining the existing processes
- Single combined permit instead of 3 permits
- Acceleration of environmental impact assessment proceedings
- Simplification of renewal of electric wind turbines

- Grid development
- New radars to invalidate height restrictions
